## Establishment of Anti Ragging Committee

The committee is formed under the "AICTE (Prevention and Prohibition of Ragging in Technical Institutions) Regulations, 2009 Notification Number: F.No. 37-3/Legal/AICTE/2009 Dated: July 1, 2009. This regulation was framed using the powers conferred under **Section 23 read with Section 10** of the AICTE Act, 1987.

According to the 2009 Regulations, the following sections make the formation mandatory under **Section 6(a)** for every institution to constitute an **Anti-Ragging Committee**. This committee must be headed by the Head of the Institution (Director/Principal) and include representatives from Faculty members, Students and Non-teaching staff. Mandates the formation of an **Anti-Ragging Squad**. Unlike the committee, the squad consists only of internal staff members for surprise raids in hostels and corridors.
